

Kristie's Foundation American Systems BBQ Raffle

Raffle tickets are \$5.00 each or \$20 for 5 tickets. Payable to Kristie's Foundation. Raffle tickets must be purchased by 3:00 p.m. on Saturday June 12, 2010. Only ticket holders with validly paid tickets are eligible to participate in the raffle. Kristie's Foundation & Big Pig BBQ assumes no responsibility for lost, late, misdirected or non-delivered mail or other failure to deliver tickets prior to any deadline. Purchases of raffle tickets are not tax-deductible contributions.

Tickets may be purchased online at www.Kristies.org or at the OC BBQ Festival on June 12, 2010 at the Orange County Fair & Event Center in Costa Mesa, Ca and paid for by cash, check or credit card. Check and credit card for pre-sale tickets only. Online purchases must be paid by credit card. Purchases may be made by phone, at (714) 408-9781 or by mail to Kristie's Foundation – BBQ Raffle 1747 S. Claudina Way Anaheim, Ca 92805. You may buy as many available tickets as you want.

The winning ticket will be drawn at random on or about 4 p.m. Saturday June 12, 2010 from all eligible raffle tickets received. Kristie's Foundation will conduct the drawing at the OC BBQ Festival (88 Fair Drive Costa Mesa, Ca 92626). Ticket holders do not need to be present to win. However, the winner is obligated to take receipt of the BBQ at the event venue no later than 3pm on Sunday June 13, 2010. If not present for the drawing, the winner will be notified by phone according to the contact information provided to Kristie's Foundation at the time of ticket purchase. The odds of winning the prize will depend on number of raffle tickets sold.

You must be 18 years of age or older (or have consent from a parent or legal guardian) to purchase tickets or win the prize.
